Directions to Arlene Towle's

From the South, take exit 36 from I-95, exit to Industrial Park Road South. Turn right onto Rte. 112 North. Go 7.8 miles to stoplight and turn right on to Rte. 202. Go 3.5 miles and turn left on to Waterman Road. Go 1 mile to 235 Waterman on the right.

From the North, take exit 48 onto Rte. 25 West. Stay on Rte. 25 West through Gorham and take a left onto Rte. 202 and 4 South. Go approximately 3 miles and turn right onto Waterman Road. Go 1 mile to 235 Waterman Road on the right.
